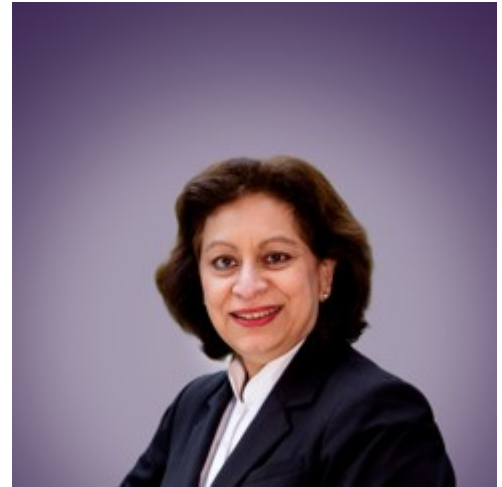

Practice Overview

Ayesha acts frequently in public law cases on behalf of the parents or the guardian

She deals with complex and difficult financial remedy cases and in all children matters including Schedule 1 (financial provision for children matters).

Ayesha acted in the leading case of its time LVMH (2000) when the court of appeal heard the conjoined appeals of 4 cases and set out what later became the guidelines in dealing with the impact of domestic abuse on children and the precursor to PD12J of the Children Act.

Ayesha has acted successfully for parents in matters pertaining to leave to remove children be it within or outside the jurisdiction. She also deals with issues arising under the Family Law Act and TOLATA.

Ayesha has been in cases involving Forced Marriage and appeared in the reported case of Chief Constable, A v YK and ors (forced marriage) [2010] EWHC 2438
